

IMPROVE OUR IMPACT ON EMISSIONS

TRANSPORTATION IS A SIGNIFICANT CONTRIBUTOR TO GREENHOUSE GAS EMISSIONS. TO IMPROVE OUR IMPACT ON EMISSIONS, WE CAN ADOPT THE FOLLOWING PRACTICES:

- a) Utilize public transportation or carpooling whenever possible to reduce individual vehicle emissions.
- b) Choose fuel-efficient and low-emission vehicles, including electric or hybrid cars, for personal use.
- c) Promote non-motorized transportation options like walking or cycling for short distances.



MONITOR OUR WASTE MANAGEMENT

EFFECTIVE WASTE MANAGEMENT CAN MINIMIZE EMISSIONS AND CONSERVE RESOURCES:

- a) Practice the three Rs (reduce, reuse, recycle) to minimize waste production.
- b) Compost organic waste, which not only reduces landfill emissions but also provides nutrient-rich soil for gardening.
- c) Dispose of hazardous materials properly to prevent their damaging impact on the environment.



IMPROVE OUR ENERGY CONSUMPTION

ENERGY CONSUMPTION ACCOUNTS FOR A LARGE PORTION OF GLOBAL EMISSIONS. TO REDUCE OUR IMPACT, FOCUS ON EFFICIENT ENERGY USE AND RENEWABLE SOURCES:

- a) Using energy-efficient appliances and electronics that consume less electricity, and switching off appliances not in use.
- b) Using compact fluorescent or LED light bulbs which not only consume less energy but also last longer.
- c) Recommend using solar panels or consider using renewable energy sources, such as wind power to our clients
- d) Recommend proper insulation to minimize heating and cooling energy requirements.
